High Definition Frequently Asked Questions

Q: Why shoot our wedding in High Definition?

A: Because it looks AMAZING!! High Definition videos are crystal clear, highly detailed, and the colors are stunning. Why wouldn't you want to highlight your special day in the highest quality available? If you haven't done so already, chances are you are going to be throwing out your old TV and upgrading to a new High-Def TV within the next few years. Why not have your wedding video recorded in a format that will look terrific with 21st century technology? Don't settle for an outdated and mushy square picture, when you can have a gorgeous movie on a widescreen television!

Q:I don't have a HD-DVD player or Blu-ray player so does that exclude me?

A: It doesn't matter. Our packages and editing are designed so that we shoot HD but provide the footage on common place DVDs. You'll be able to watch a much clearer and dynamic picture on your old DVD players, computers, and older tvs. What makes the difference is the high quality cameras we use. If you are talking to other videographers, ask them what type of cameras they use. Chances are they don't compare to ours.

Q: Just what is High Definition?

A: High Definition (HD) is video footage with a higher resolution (smoother, clearer images) than standard-definition (SD) video. HD resolution can be 960x720 (720p) or 1920x1080 (1080i or 1080p). SD resolution is a meager 640x480. What does this all mean? High Definition provides beautiful color, sharp images, and looks simply wonderful!

Q: What kind of cameras do you shoot on?

A: We choose from three different cameras depending on your package and wedding requirements. They are the Panasonic HPX500, the Sony Z1u, and the Panasonic HVX. Look them up if you're curious. They are fantastic HD cameras perfect for weddings.

Q: Would Don Schechter (the owner of CRMG) shoot his wedding on HD?

A: He would and he did. In fact there were three CRMG HD shooters filming along side our friend and collaborator Lukas Photography. Check out our website and DVD promos to see this powerhouse combination!

Terms and Conditions

- 1. **Services:** The parties agree that Charles River Media Group will provide video and editing services outlined in this document. Additional services may be purchased on an as needed basis if agreed upon in writing by both parties.
- 2. **Payment Policy:** A deposit of half the full amount is paid to reserve the necessary filming and editing times. No work will commence until this retainer fee is paid. This fee will be applied to the total cost of the order. The balance must be paid 14 days prior to the wedding.
- 3. **Cancellation:** If the client cancels this Agreement sixty (60) or more calendar days before any services are rendered, any payments made to Charles River Media Group shall be refunded in full. If Client cancels this agreement within less than sixty (60) days of the wedding, and if Charles River Media Group does not obtain another assignment for that date, the deposit will not be refunded.
- 4. **Limitation of Liability:** While every reasonable effort will be made to produce and deliver outstanding video production and post-production services, Charles River Media Group’s entire liability to Client for any claim, loss, or injury arising from Charles River Media Group’s performance is limited to a partial or full refund to Client of fees paid. This limitation on liability shall also apply to any and all circumstances beyond the foreseeable control of Charles River Media Group.
- 5. **Federal Copyright Laws:** Charles River Media Group owns all copyright for any and all images, both still and motion, produced in connection with this agreement, including the right to reproduce or display such images.
- 6. **Inherent Qualities:** Client is aware that videography equipment may temporarily malfunction and that videotape and batteries needs to be changed hourly causing a few moments to be missed while repair or additional videographers or equipment is utilized. Client release Charles River Media Group from any liability for any claims whatsoever based upon such instances.
- 7. **Delivery:** Following notification of completion of order, unpaid balance will be subject to a 1.5% monthly service charge. We are not responsible for footage, raw or edited, left unclaimed 7 days after delivery. Shipment of edited video is typically made within 2 – 3 months, if not sooner.

The parties have read this Agreement, agree to all its terms, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as Client below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.
